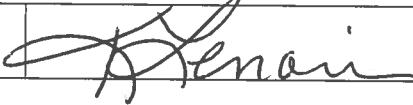

1. Purpose

The purpose of this policy is to establish a key element of the financial stability of the City by setting guidelines and parameters for fund balance / working capital of the various funds used by the City of Brady. Unassigned fund balance/ working capital are an important measure of economic stability. It is essential that the City maintain adequate levels of unassigned fund balance to mitigate financial risk that can occur from unforeseen revenue fluxuations, unanticipated expenditures, and similar circumstances. Advantages of a fund balance / working capital policy are as follows:

- Enhances the quality of decisions by imposing order and discipline
- Promotes consistency and continuity in decision making
- Demonstrates a commitment to long term financial planning objectives

2. Definition

Fund Equity – A fund's equity is generally the difference between its assets and its liabilities.

Fund Balance – An accounting distinction is made between the portions of fund equity that are spendable and nonspendable. Those are broken up into five categories:

1. **Nonspendable Fund Balance** – includes amounts that are not in spendable form or are required to be maintained intact.
2. **Restricted Fund Balance** – includes amounts that can be spent only for the specific purposes stipulated by external resource providers either constitutionally or through enabling legislation.
3. **Committed Fund Balance** – includes amounts that can be used only for the specific purposes determined by a formal action of the City Council. Commitments may be changed or lifted only by the City Council taking the same formal action that imposed the constraint originally.
4. **Assigned Fund Balance** – comprises amounts intended to be used by the City for specific purposes. Intent can be expressed by the City Council or by an official or body to which the City Council delegates the authority. In governmental funds other than the general fund, assigned fund balance represents the amount that is not restricted or committed. This indicates that the resources in other governmental funds are, at a minimum, intended to be used for the purpose of that fund.
5. **Unassigned Fund Balance** – is the residual classification of the general fund and includes all amounts not contained in other classifications. Unassigned amounts are technically available for any purpose.

3. Policy Statement

Committed Fund Balance

The City Council is the City's highest level of decision making authority and the formal action that is required to be taken to establish, modify, or rescind a fund balance commitment is an ordinance or resolution approved by the Council at the City's Council meeting. The ordinance or resolution must either be approved or rescinded, as applicable, prior to the last day of the fiscal year for which the commitment is made. The amount subject to the constraint may be determined in the subsequent period.

Assigned Fund Balance

The City Council has authorized the City Manager or Director of Finance as the officials authorized to assign fund balance to a specific purpose as approved by this fund balance policy.

Unassigned Fund Balance

The unassigned fund balance for the General Fund of the City of Brady will be maintained at a level sufficient to provide the required resources to meet operating cost needs, to allow for unforeseen needs of an emergency nature, and to permit orderly adjustment to changes resulting from fluctuation of revenue funds.

4. Order of Expenditure of Funds

When multiple categories of fund balance are available for expenditure, the City will start with the least restricted category and spend those funds first before moving down to the next category with available funds.

5. Funding Levels

The City establishes the following funding levels concerning unassigned fund balances / working capital in the various funds used by the City of Brady:

- The annual budget shall be presented to Council, with each fund reflecting **minimum** ending fund balances / working capital as follows:

General Fund	An amount no less than 60 days of operating expenditures (approximately 15%) until an amount equal to 90 days (approximately 25%) can be achieved.
Utility Funds	
Electric/Sewer	180 days of operating expenditures
Water	(approximately 50%)
Gas	
Utility Support	90 days of operating expenditures
Solid Waste	(approximately 25%)
Special Revenue Fund	90 days of operating expenditures
	(approximately 25%)

- The operating expenditures are exclusive of capital outlay.
- Fund balances, which exceed the minimum levels established for each of the funds, may be appropriated for non-recurring capital projects or programs. The Council recognizes that any such funds should be appropriated for non-recurring expenditures as they represent prior year surpluses that may or may not materialize in subsequent fiscal years.

6. Monitoring and Reporting

The computation of the required balances shall occur at least twice a year.

1. The first computation shall occur after the audit is presented to City Council. The fund balance/working capital as of September 30 of the year of the audit shall be compared to the budgeted operating expenditures for the fiscal year following the audit.
2. The second computation shall occur during the budget process for the next fiscal year. The estimated fund balance/working capital for the current fiscal year shall be compared to the estimated operating expenditures ~~for that same- of the new fiscal year budget~~.

7. Replenishment

Should the fund balances fall below the targeted level, the City Council must approve and adopt a plan to restore the balance to the targeted level within two (2) years. If restoration can not be accomplished within such period without severe hardship, then the City Council will establish a different but reasonable time period.

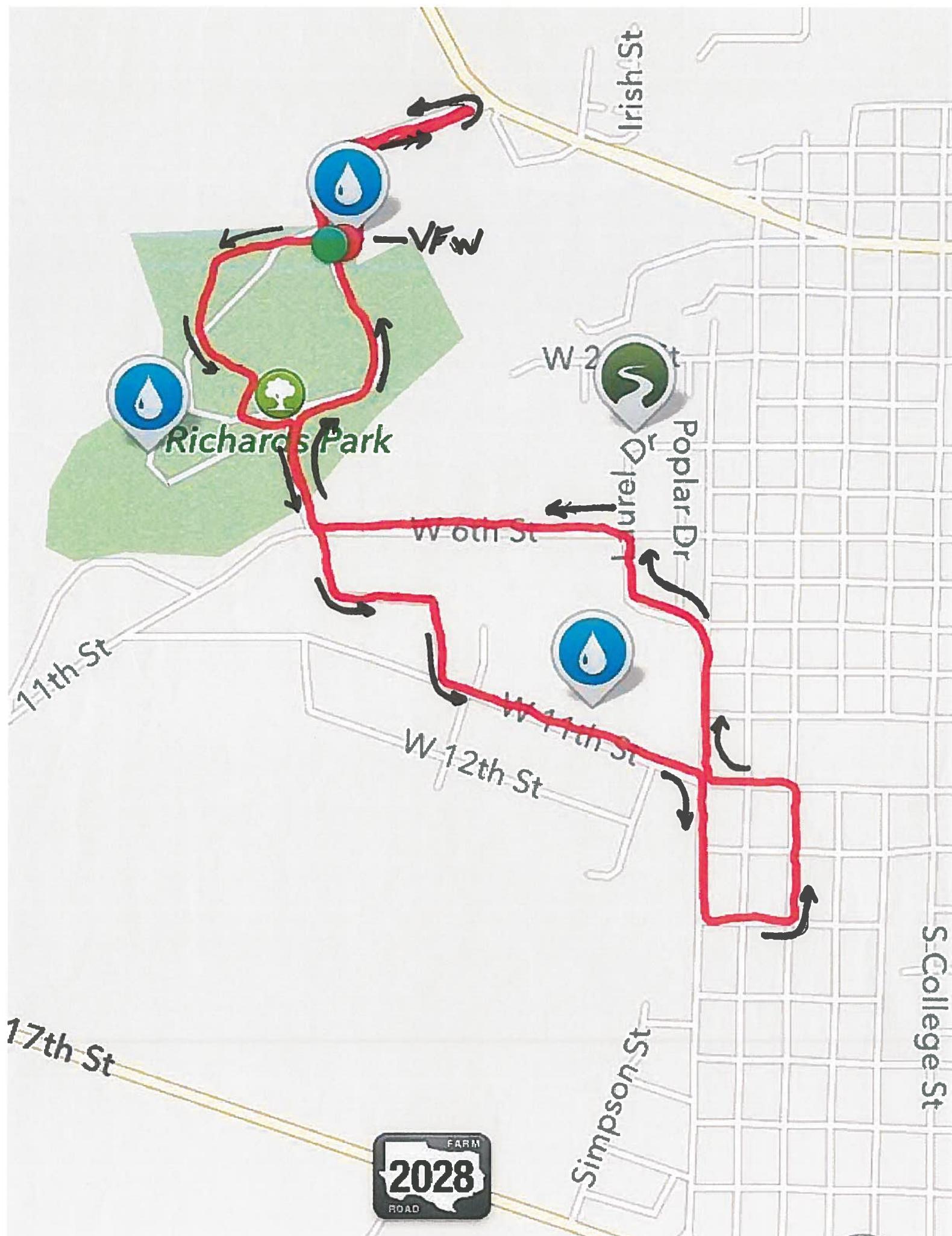

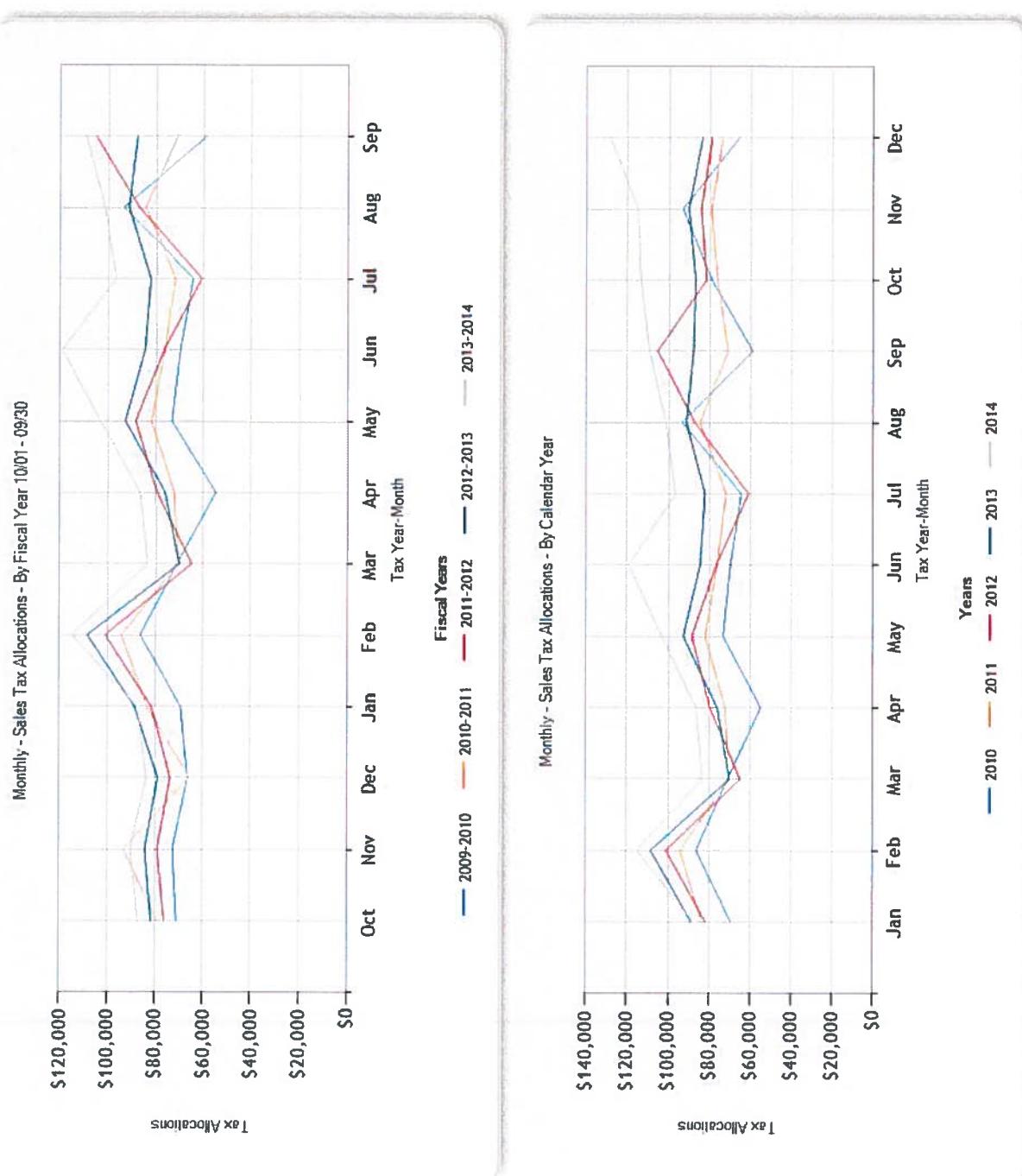

OPEN FOR BUSINESS – OR ARE WE?

THE RESTRICTIONS OF THE OPEN MEETINGS ACT

The only way a municipality can act is by and through its governing body.¹ It is a well-settled rule that the governing authorities of cities can express themselves and bind the cities only by acting together in a duly assembled meeting.² That is, decisions entrusted to the governmental body must be made by the body as a whole at a properly called meeting.³ This requirement gives each member of the governmental body an opportunity to state his or her views to other members of the body and to give them the benefit of his or her judgment, so that the decision “may be the composite judgment of the body as a whole.”⁴ Decisions cannot be made by individual council, board or commission members. Rather, a city council can only transact a city’s business transactions upon a majority vote of the city council.⁵

1. HOW DOES THE TEXAS OPEN MEETINGS ACT APPLY?

Generally speaking, the Texas Open Meetings Act (“Act”) applies anytime a quorum of a council, board or commission is present and discusses public business. (There are limited exceptions to this rule for attendance at a social gathering, convention, workshop, press conference or some ceremonial event that is not related to the entity’s public business, any discussion regarding public business is merely incidental, and no vote or action is taken.⁶) Under the Act, a quorum is considered to be a simple majority of the members of the council, board or commission unless there is some specific quorum requirement to the contrary.⁷

2. WHAT RESTRICTIONS DOES THE TEXAS OPEN MEETINGS ACT IMPOSE ON A GOVERNMENTAL BODY’S ABILITY TO OPEN FOR BUSINESS?

a. The Act requires meetings to be accessible to the public.

The Texas Open Meetings Act is liberally/broadly construed in favor of “open government.”⁸ While the phrase “open government” is not specifically defined, the breadth intended thereby is expressed as follows:

Every regular, special, or called meeting of a governmental body shall be open to the public, except as provided by this chapter.⁹

The Act is intended to open to public scrutiny the process by which governmental bodies reach decisions affecting public policy or business over which the governmental bodies have supervision or control.¹⁰ The executive and legislative decisions of local governmental officials as well as the underlying reasoning behind such decisions must be discussed openly before the public rather than secretly behind closed doors.¹¹ Citizens are entitled not only to know what government decides but to observe how and why every decision is reached.¹² The explicit command of the Act is for openness at every stage of the deliberations.¹³ Absent compelling reasons to the contrary, the public business should be conducted in public.¹⁴

In order to avoid frustrating the intent of the Act, meetings of a governmental body must be held in a location that is accessible to the public.¹⁵ A governmental body simply cannot meet in an inaccessible location. While the public is not entitled to choose the items to be discussed or to speak about items on the agenda,¹⁶ the public must be permitted to attend a meeting that is “open” to the public.¹⁷

b. The Act requires advance written notice of any meeting to the public.

The Act requires that the governmental body give the public advance written notice of the date, hour, place, and subject of each meeting held by the governmental body.¹⁸ This advance written notice must identify the items that will be discussed in both an open session and a closed session of a meeting.¹⁹ This notice typically takes the form of an agenda listing the items to be discussed or considered by the governmental body during its meeting. The notice/agenda must be sufficient to apprise the public in general terms of the subjects to be considered during the meeting. Generalized terms such as “old business,” “new business,” “regular or routine business,” and “other business” are not proper terms to give notice of a meeting because they do not inform the public of its subject matter.²⁰ But the term “public comment” provides sufficient notice of a “public comment” session, where the general public addresses the governmental body about its concerns and the governmental body does not comment or deliberate, except as authorized by section 551.042 of the Texas Government Code.²¹ However, the foregoing is not the case if the governmental body is aware, prior to the meeting, or reasonably should have been

aware of specific topics to be addressed by the public.²² A number of reported cases, when taken together, indicate that the more important a topic of discussion is to the public, the more detail that must be provided in the notice/agenda regarding that matter.²³

Officers and employees of the governmental body must be careful in preparing the notice/agenda for a meeting to avoid deliberations that are subject to the Act.

c. Timing and posting of such advance written notice to the public

The notice/agenda of a meeting of a governmental body must be posted in a place readily accessible to the general public at all times for at least 72 hours before the scheduled time of the meeting.²⁴ For a municipal governmental body the notice/agenda must be posted on a physical or electronic bulletin board at a place convenient to the public in city hall.²⁵ In addition, a municipal governmental body must also concurrently post the notice/agenda of the meeting on the municipality's Internet website.²⁶ There is some good news to this redundancy in posting. Because a municipality is specifically required to post the notice/agenda of a meeting on the Internet:

- (1) the requirement that the notice/agenda must be posted in a place readily accessible to the general public at all times is satisfied by making a good-faith attempt to continuously post the notice/agenda on the Internet during the prescribed period;
- (2) the notice/agenda must still be physically posted at a particular location in city hall; but
- (3) the notice/agenda physically posted at the location inside city hall is only required to be readily accessible to the general public during normal business hours if the governmental body makes a good-faith attempt to continuously post the notice/agenda on the Internet during the prescribed period.²⁷

d. Items that are not properly noticed or included on the agenda cannot be discussed.

If a member of the public or a member of the governmental body raises a subject that has not been properly noticed, or set out in the agenda, for the meeting any discussion regarding the

matter must be limited to a proposal to place the item on the agenda for a future meeting.²⁸ The person raising such a matter could also be provided a statement of specific factual information or a recitation of existing policy responsive to the inquiry without violating the Act.²⁹ Sometimes the very wording of the notice/agenda for a particular matter that is properly noticed for discussion can unintentionally limit the scope of discussion permitted on that matter.

e. **The Texas Open Meetings Act has also been applied to meetings of less than a quorum of the members of a governmental body.**

1. **Subcommittees**

In 1989 the Texas Attorney General extended the Act to subcommittees of governmental bodies that are subject to the Act because the governmental body “might simply ‘rubber-stamp’ the committee’s recommendations” thereby depriving the public of access to the decision-making process.³⁰ Similarly, the courts have found that a committee comprised of five members of a fifteen-member city council was subject to the requirements of the Act.³¹ Even a committee appointed by a governing body having only two members of the governmental body serving with seven non-members was deemed by the Attorney General as being subject to the Act.³²

2. **No meeting or deliberation of the governmental body required**

In 1992 the Attorney General opined that when a quorum of a city council signed a letter, even in their individual capacities, that related to public business a violation of the Act occurred despite the fact there was never a meeting between a quorum of the individual council members at which the letter was discussed and an agreement reached.³³ The Attorney General also noted in that opinion that the Act’s “requirements are not necessarily avoided by avoiding the physical gathering of a quorum in one place at one time.”³⁴ Then in 2000, the Attorney General again noted that “the Act has been construed to apply to situations in which members of a governmental body act as a body but are not in each other’s physical presence.”³⁵ In fact, the Attorney General specifically stated that avoiding the technical definition of “meeting” or “deliberation” will not protect participants from the application of the Act.³⁶ This opinion essentially does away with the requirement that a “meeting” or “deliberation” be held, as those terms are defined by the Act, before the Open Meetings Act applies.³⁷ In addition, the Attorney General also opined that members of a governmental body could violate the Act by using third persons as intermediaries to hold a closed meeting or to meet in numbers of less than a quorum.³⁸

3. Telephone, facsimile and e-mail communications

Former Attorney General Morales noted “[i]t is possible for members of a governmental body to violate the Open Meetings Act even [though] they are not physically present in one place, for example, by discussing public business of the governmental body over the telephone.”³⁹ A commissioners court’s approval (or attempted approval) of payment of a claim, invoice, or bill given by members in writing in lieu of consideration of the matter at a meeting held under the Act would violate the Act’s requirement that a vote, decision, or final action on a matter be taken in a properly noticed open meeting.⁴⁰ In addition to violating the Act by discussing matters via telephone or in writing, the Attorney General has indicated that “deliberation” could also include facsimile transmissions and electronic mail.⁴¹

4. Walking Quorum

A “walking quorum” occurs when members of a governmental body meet in a series of meetings in person or via phone or other electronic communication in numbers less than a quorum to discuss public business and avoid the requirements of the Act. A walking quorum is described in the case of *Esperanza Peace and Justice Center v. City of San Antonio*.⁴² In *Esperanza*, the mayor met with several city council members in the city manager’s office and spoke with others by telephone about the city budget on the night before a city council meeting was noticed to be held. A decision was reached that night by the members of the city council and ratified at the public meeting the next day. The court said that a meeting of less than a quorum is not subject to the Act “when there is no intent to avoid the Act’s requirements.”⁴³ The court further stated:

On the other hand, the Act would apply to meetings of groups of less than a quorum where a quorum or more of a body attempted to avoid the purposes of the Act by deliberately meeting in groups less than a quorum in closed sessions to discuss and/or deliberate public business, and then ratifying their actions as a quorum in a subsequent public meeting.⁴⁴

5. City of Alpine, Texas

The recent situation involving the Alpine City Council is particularly instructive in this regard. Three members of the Alpine City Council, a five member body, exchanged private e-mails regarding whether to call a public meeting to consider a public contract matter.⁴⁵ At least two of the Alpine City Council members were indicted in state court for violations of the criminal provisions of the Texas Open Meetings Act.⁴⁶ After prosecuting the charges against the

individual City Council members for several months, the district attorney dismissed the charges without prejudice to re-filing such charges.⁴⁷ The City Council defendants filed a lawsuit in the federal courts challenging the constitutionality of the Act as an undue restriction of their First Amendment speech rights and seeking both declaratory and injunctive relief against the Texas Attorney General and the District Attorney.⁴⁸ Ultimately, this litigation was dismissed by the United States Fifth Circuit Court of Appeals for mootness because the plaintiffs in the lawsuit completed their terms of office as City Council members prior to the issuance of the final decision on the merits of this lawsuit.⁴⁹

A new suit challenging the constitutionality of the Act was filed on December 14, 2009.⁵⁰ The trial court rejected the public officials' challenges in that matter and held that the Act only punishes members of governmental bodies "when those members hide that speech from Texas citizens in closed meetings. [The Act] neither suppresses the speakers' viewpoint nor the content of his or her speech. Rather, [the Act] protects the compelling interest of government transparency."⁵¹ The case is now on appeal in the Fifth Circuit.

6. Social Networking and Social Media

The Senate Committee on State Affairs prepared an Interim Report to the Eighty-second Legislature regarding the challenge that new technologies present in complying with the Act. The Committee reported in pertinent part as follows:

The walking quorum concept combined with newer technologies such as microblogs (e.g., Twitter), social media websites (e.g., Facebook), text messaging and instant messaging, raise new issues for consideration by the Attorney General, the courts and the Legislature. Neither the courts nor the Attorney General have determined the applicability of the [Act] to these new technologies; however, under the current interpretations of the Act, a quorum would exist if a majority of the governmental body discusses public business on a Facebook wall. The Facebook wall could be closed to the public, or open; however, absent prior notice of the "meeting" the [members of the governmental body] could be in violation of the [Act]. A similar situation could arise with Twitter where members can have public or private accounts.

3. CONCLUSION

Sometimes you will find out that despite your council's, board's, or commission's best efforts to be open for business you simply cannot consider a particular matter until your next meeting date because of the restrictions imposed upon governmental bodies by the Texas Open

Meetings Act. When a majority of a public decision-making body is considering a pending issue, there can be no “informal” discussion under the Act.⁵² There is either formal consideration of a matter in compliance with the Act or an illegal meeting.⁵³ It is the process of building a consensus or reaching a meeting of the minds that the Act is intended to open to public scrutiny.

As a result there may often be times when the Texas Open Meetings Act will conflict with standard everyday practices in the private sector. It may frequently be frustrating to both the members of the governmental body and the public that a matter which is raised by a member of the public or the governmental body cannot be discussed because it is not properly noticed and included on that meeting’s agenda. But it is the broader right of the public to know the workings of its government that controls. If you have any questions or concerns regarding the wording of a particular agenda item or the absence of a topic, which is being raised for discussion, from the notice/agenda that was provided in advance to the public do not hesitate to ask your city attorney about the propriety of discussing such matters because violations of the Texas Open Meetings Act may subject the governmental body’s action(s) to revocation and possibly, in certain factual situations, subject the members of the governmental body to potential criminal liability.
