C. Discussion, consideration and possible action regarding the first reading of Ordinance 1351 of the City of Brady, Texas approving request for a Residential Group R1 use as a Specific Use Provision, for a Central Business District property, for the purpose of retreat center for property located at 100 N. Blackburn in the Fulcher Subdivision, Block 3, Lots 8-9. Code Enforcement Officer Connie Echols informed council about stipulations which were requested by Planning & Zoning. Council Member Elliston asked why they would have these stipulations. Connie said they’re concerned about future owners and uses. Council Member Huffman said the ordinance needs to be brought back for changes to allow for rentals. Council Member Elliston agreed. Council Member Elliston said she thinks they should be able to rent units as a BnB. Council Member Huffman asked that an amendment to the zoning ordinance be put on a future agenda to allow for rental. Mayor Groves asked if the discussion was because of the Central Business District zoning and that definition that goes along with Central Business District. Connie said yes. Mayor Groves said we might need to work on the zoning rather than an ordinance. Council Member May said the existing ordinance already covers the stipulations requested by Planning & Zoning. Council Member Elliston moved to approve the first reading of Ordinance 1351. Seconded by Council Member Huffman. All Council Members voted “aye” and none “nay”. Motion passed with a 4 – 0 vote.

D. Discussion, consideration and possible action to nominate members for the McCulloch County Appraisal District Board of Directors. Council Member May said he would recommend Jerry DeBord. Mayor Groves said we could choose not to nominate anyone and bring back to cast votes. Council Member Sutton asked if council members are disqualified to be on the Board. Mayor Groves said he doesn’t think so. Council Member Huffman said she would think that would be a conflict. Council Member May said he had to get off a board before he was elected. There were no nominations. Council Member May moved to not propose a nominee. Seconded by Council Member Elliston. All Council Members voted “aye” and none “nay”. Motion passed with a 4 – 0 vote.

WHEREAS, the City Council of the City of Brady in cooperation with the State of Texas for the safety and convenience of the traveling public request temporary closure of US Highway 87 in Brady from High Street to the Courthouse Square, along with two-lane Ranch Road 714, and two-lane US Highway 190/and Highway 377 around the courthouse square from approximately 3:00 p.m. to 6:30 p.m. on Saturday, December 11, 2021 and the east half of the square remaining closed until 9:30 pm. for the 7th Annual Christmas in the Heart Lighted Parade; and

ORDINANCE NO. 1351

AN ORDINANCE OF THE CITY OF BRADY, TEXAS, APPROVING REQUEST FOR A RESIDENTIAL GROUP R1 USE AS A SPECIFIC USE PROVISION, FOR A CENTRAL BUSINESS DISTRICT PROPERTY, FOR THE PURPOSE OF A RETREAT CENTER FOR PROPERTY LOCATED AT 100 N. BLACKBURN STREET IN THE FULCHER SUBDIVISION, BLOCK 3, LOT 8-9.

WHEREAS, Chapter 211 of the Texas Local Government Code empowers the City of Brady, Texas to enact zoning regulations and provide for their administration, enforcement and amendment; and

WHEREAS, the City has previously deemed it necessary and desirable to adopt zoning regulations to provide for the orderly development of property within the City in order to promote the public health, safety, morals and general welfare of the residents of the City, and

WHEREAS, Chapter 14 of the Brady Code of Ordinances constitutes the City's Zoning Regulations and requires property to be zoned in accordance with proper designations as defined by the City; and

WHEREAS, Mrs. Joanne Heady has requested a Specific Use Provision, and

WHEREAS, the Planning and Zoning Commission of the City provided adequate notice and held a public hearing on October 11, 2022 in accordance with the Brady Code of Ordinances and Chapter 211 of the Texas Local Government Code; and

WHEREAS, the Planning and Zoning Commission of the City recommended approval of the Specific Use Provision of the designated property and confirmed that the Specific Use Provision is uniform and conforms to the plan design of the City's Zoning regulations; and

WHEREAS, the City Council believes the Specific Use Provision will not adversely affect the character of the area in which it is proposed; will not substantially depreciate the value of adjacent or nearby properties; will be in keeping with the spirit and intent of the City's Zoning Ordinance; will comply with applicable standards of the district in which located; and will not adversely affect traffic, public health, public utilities, public safety and the general welfare of the residents of the City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRADY, TEXAS, THAT:

A Specific Use Provision is granted for a Central Business District property for the purpose of a retreat center for property located at 100 N. Blackburn Street in the Fulcher Subdivision, Block 3, Lots 8-9.

SUMMARY:
Lance Grove requested a Specific Use Provision for his property at 401 S. Pine Street, Brady Texas to allow for an enclosed 8-9 foot fence on the front of his property. Planning and Zoning denied the request because the fence does not meet zoning ordinances and does not qualify for a hardship variance.


