RESOLUTION AND ORDER NO. 2025-025

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRADY, TEXAS
CANVASSING RETURNS AND DECLARING THE RESULTS OF A SPECIAL
ELECTION HELD ON NOVEMBER 4, 2025, FOR CITY OF BRADY CITY COUNCIL
PLACE 4 UNEXPIRED TERM.**

WHEREAS, the City Council of the City of Brady, duly authorized a special election to be held within the City of Brady, Texas (the “City”) on November 4, 2025, for the purpose of electing City Council Place 4 Unexpired Term; and

WHEREAS, this City Council has investigated all matters pertaining to said and special election; and

WHEREAS, the election officer who held said elections has duly made the returns of the results thereof, and said returns have been duly delivered to the City Council; and

WHEREAS, it is officially found and determined that the said elections were duly ordered, that proper notice thereof was duly given, that proper election officers were duly appointed prior to said elections, that said elections were duly and lawfully held, that due returns of the results of said elections have been made and delivered, and that the City Council has duly canvassed said returns, all in accordance with law and the Ordinance calling said election.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF BRADY, TEXAS:

Part 1. That all of the findings contained in the preamble of this Resolution are found to be true and are adopted as findings of fact.

Part 2. That the tabulation of votes cast for the office of Council Member Place 4 in the Special Election held on November 4, 2025, made and certified to by the City Secretary of the City of Brady, Texas, be and the same is hereby adopted as the official tabulation filed and recorded in the official records of the City of Brady as the official canvass of said Special Election.

Part 3. No person received more than a 50% majority of all votes cast for the candidates and accordingly no one is declared elected and a runoff election shall be called by the City Council in accordance with the Texas Election Code; and that the number of votes cast for each person who was a candidate is shown below.
