1. CALL TO ORDER, ROLL CALL & CERTIFICATION OF A QUORUM

Mayor Groves called the meeting to order at 6:00 p.m. Roll was then called for Council and a quorum was certified.

Council Member Doyal gave the invocation, and the Pledge of Allegiance was recited.

Director of Public Works Steven Miller introduced Enprotech/Hibbs & Todd. Keith Kindle and Joshua Barnhill presented to Council. After presentation, Charlotte Harper had positive comments relating to the project.

- A. Discussion, consideration and possible action regarding next step for Drinking Water / Radium Reduction Final Design. Director of Public Works Steven Miller advised of staff’s recommendation to accept the presented proposal. Council Member Gendusa made a motion to approve. Seconded by Council Member Turk. All Council Members voted “aye” and none “no”. Motion carried.

Discussion, consideration and possible action regarding Resolution 2015-001 (to apply for CDBG for Water Project) A resolution of the City of Brady Texas, authorizing the submission of a Community Development Block Grant application to the Texas Department of Agriculture for the Community Development Fund; and authorizing the Mayor to act as the Executive Officer and authorized representative in all matters pertaining to the participation in the Community Development Block Grant Program. (Public Hearing held prior to meeting at 5:30pm): City Manager Kim Lenoir presented to Council. After presentation Council Member Linda Lott made a motion to approve. Seconded by Council Member Gendusa. All Council Members voted

“aye” and none “no”. Motion carried.

Discussion, consideration and possible action appointing three (3) Members to alternates to Zoning Board of Adjustments one (1) alternate to the Planning and Zoning Commission, and one (1) member for Charter Commission: Former Alternate ZBA Member Holly Groves volunteered to move to a primary position on the ZBA. Council Member Turk made a motion to approve. Seconded by Council Member Gendusa. All Council members voted “aye” and none “no”.
- D. Discussion, consideration, and possible action regarding first reading of Ordinance No. 1168, of the City of Brady (amending Municipal Court procedures) by adding Article 7.300 to the City of Brady Code of Ordinances dividing the Brady Municipal court into two divisions – General State Law Division and City Code Enforcement Division: City Manager Kim Lenoir presented to council. Council Member Lott made a motion to approve. Seconded by Council Member Gendusa. All Council Members voted “aye” and none “no”. Motion carried.
- E. Designate one Council Member as a member of the Hotel Occupancy Tax Grant Review Committee Director of Community Services Peter Lamont presented to Council. Council Member Turk volunteered for the committee. Council Member Doyal made a motion to approve. Seconded by Council Member Gloria. All Council Members voted “aye” and none “no”. Motion carried.
