Council approved Resolution 2016-027 on May 3, 2016 authorizing the temporary closure of the East side of Brady Square on Saturday, September 3, 2016. It has become necessary for the additional closure of N. Blackburn Street between E. Lockhart and E. Main beginning at 7:00 p.m. on Friday, September 2, 2016 thru 2:00 a.m. on Sunday, September 4, 2016. for the construction of a stage to be used for the street dance.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRADY, TEXAS TO ENTER INTO AN AGREEMENT WITH THE STATE OF TEXAS THROUGH THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE TEMPORARY CLOSURE OF FOUR LANE US HIGHWAY 87 EAST AND WEST GOING INTO AND FROM BRADY; TWO LANE US HWY 377/190; AND TWO LANE FM 714 ON JULY 2, 2016 FOR THE ANNUAL JULY JUBILEE PARADE AND FOR THE TEMPORARY CLOSURE OF THE NORTH EAST CORNER OF THE SQUARE IN BRADY ON SEPTEMBER 3, 2016 FROM 8:00 P.M. TO 1:00 A.M. ON SEPTEMBER 4, 2016 FOR THE 43<sup>RD</sup> ANNUAL WORLD CHAMPIONSHIP GOAT COOK-OFF DANCE AND FOR NOISE VARIANCES.**

**WHEREAS, the City Council of the City of Brady in cooperation with the State of Texas for the safety and convenience of the traveling public request temporary closure of four lane US Highway 87 West and East going into and from Brady; two lane US Hwy 377/190; and two lane FM 714 on July 2, 2016 for the Annual July Jubilee Parade; and**

**WHEREAS, the July Jubilee parade will be held within the City of Brady incorporated area from approximately 10:00 a.m. until 11:00 a.m. and the closure will be performed within the State's requirements; and**

**WHEREAS, the July Jubilee Dance will be held on Saturday, July 2 2016 at Richards Park within the City of Brady incorporated area from approximately 3:00 p.m. until 1:00 a.m. on July 3 ,2016 and the noise levels will be greater than normal, thus requiring a variance from Council; and**

**WHEREAS, the City Council of the City of Brady also requests the temporary closure of the East side of Brady Square on Saturday, September 3, 2016 beginning at 8:00 p.m. until 1:00 a.m. on Sunday, September 4, 2016 for the Annual World Championship Goat Cook-off Street dance **along with the temporary closure of N. Blackburn between E. Lockhart and E. Main from 7:00 p.m. on Friday, September 2, 2016 until 2:00 a.m. on Sunday, September 4, 2016;** and**

**WHEREAS, all Northbound and Southbound traffic will be routed around the West side of the Square still allowing continuous access to all routes leading to and from the City of Brady; and**

**WHEREAS, the street dance will be held within the City of Brady incorporated area from approximately 8:00 p.m. Saturday, September 3, 2016 until 1:00 a.m. Sunday, September 4, 2016 and the noise levels will be greater than normal, thus requiring a variance from Council.**

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL, CITY OF BRADY, TEXAS:**

The City Council enter into an agreement with the State of Texas through the Texas Department of Transportation for the temporary street closure of four lane US Hwy 87 West and East going into and from Brady; two lane US Hwy 377/190; and two lane FM 714 for the purpose of the Annual July Jubilee Parade on Saturday, July 4, 2016; and Council grants approval of a noise variance for the duration of the July Jubilee Dance and the Goat Cook-Off Street Dance.
